1.0 Rules and regulations:

1.1 Protective Wear

- i. Each student shall bring at least two (2) washable masks for his/her use at the University.

1.4 Visits by Outsiders in Hostels

- ii. Resident students shall not make hostel to hostel and room to room visits.

1.5 Informal Gatherings

All students shall desist from forming informal groupings of more than four (4) people

2.0 FAILURE TO OBSERVE THE HEALTH AND SAFETY RULES AND REGULATIONS

Any student who fails to abide by these rules and regulations shall have committed an offence and shall be summoned in writing to appear before the Students Disciplinary Committee for further necessary action.

3.0 PENALTIES

The penalties for failure to abide by the Regulations and rules on health and safety requirements shall include:

- 1) Handing over to law enforcers for action as per Public Health Act
- 2) Handing over to Ministry of Health for forced quarantine at own cost
- 3) Letters of warning, which will be carried in the Student's file.
- 4) Suspension from the University for a Specific Period.
- 5) Expulsion from halls of residence.
- 6) Expulsion from the University.
- 7) A combination of any two or more of the above.
- 8) Any other penalties as the committee may deem fit.

- 14) Expulsion from the University.
- 15) A combination of any two or more of the above.
- 16) Any other penalties as the committee may deem fit.
